Dog Daycare – Owner Agreement

I, _____ hereby certify that my dog(s):

is/are in good health, have not been ill with any communicable diseases or parasites in the last 30 days, and have not harmed or shown aggressive or threatening behavior towards any person or any other dog. I also have read and understand and agree to the following:

1. I understand that Unleashed Joy's Daytime Playtime involves multiple dogs playing with one another and because of this there are inherent risks, which even when closely monitored, may result in the following:

a. Transfer of a communicable illness such as, but not limited to Upper Respiratory illnesses, including Kennel Cough, also known as the Bordetella virus, "puppy warts" also known as the canine papilloma virus, or parasites.

b. Injuries, usually benign, such as broken nails, sore pads, puncture wounds, abrasions and cuts, particularly in shorter coated breeds, etc.

c. Behavioral problems.

2. If health or behavioral problems develop with my dog(s), that these will be treated as deemed best by the staff of Unleashed Joy within their sole discretion, and that I assume full financial responsibility for any and all expenses involved.

3. Unleashed Joy and their team will not be liable for any health or behavioral problems that develop in my dog(s), and I hereby release them of any liability of any kind whatsoever arising from my dog's attendance and participation at Daytime Playtime.

4. I agree to maintain regular flea, tick, and heartworm preventative maintenance programs for as long as my dog(s) has/have active attendance and participation at Unleashed Joy.

5. I am solely responsible for any harm, including to any other dog(s), to the employees or invitees of Unleashed Joy, or to the equipment, physical plant, or other property of Unleashed Joy, caused by my dog(s) while my dog(s) is/are attending Daytime Playtime.

If Unleashed Joy pursues collection proceedings, I will pay reasonable attorney's fees and costs of collection.

Payments and Late Fees

Payments are required upon bringing in dog to first session at Daytime Playtime.

1. I understand the fees schedule and agree to pay the current rate listed on Unleashed Joy's website for any services provided on the date my dog was in attendance.

2. I further understand and agree that the hours of operation are Monday - Friday from 7:00 A.M. – 6:00 P.M. and a \$10/per each 15 minutes late fee charge applies any time after 6:00 P.M. to be paid for upon arrival.

3. I understand that Unleashed Joy has the right to refuse service to my dog(s) and me at any time for any reason.

4. I understand that Unleashed Joy will charge me a \$25 handling fee for returned checks.

5. Reservations are required. Cancellations with less than 24 hours' notice and no shows will be charged full fees.
